### WHAT DOES QDS DO?

QDS provides complete services to disabled individuals who have applied or who are considering applying for Social Security Disability. We provide individuals with:

- ELIGIBILITY ASSESSMENTS
- ASSISTANCE WITH COMPLETION OF NECESSARY PAPERWORK
- OBTAINING MEDICAL & OTHER RECORDS
- FILING APPEALS
- MAINTAINING CONTACT WITH AGENCIES INVOLVED IN A DISABILITY CLAIM

Applying for Social Security disability can be a lengthy, complicated process and QDS will be with you; helping navigate your claim at every step in the process.

### IS THERE A FEE FOR SERVICES?

QDS provides a free consultation. We do not get paid a fee if you do not get paid. When benefits are awarded, the fee for our services is set by Social Security. The fee is 25% of any past due benefits with a cap of \$6,000.00, plus any cost for medical records or medical opinions. The fee does not apply to any ongoing, monthly benefit but is subtracted from any past due benefits. Your representative can answer any further questions regarding fees

### MINNESOTA STATE CONTRACT

QDS maintains a contract with the Minnesota Department of Human Services, which allows QDS to waive fees in special circumstances. This only applies to MN residents in specific situations. Your representative will be able to provide more details at the initial appointment.
